Wildfire officials celebrate 3 years of decreased wildfires in Utah



Instead of facing a wildfire-prone season fueled by substantial growth in vegetation from a snowy year, state and federal authorities marked the conclusion of three successive years with decreasing wildfire numbers.

Fire officials with the Utah Division of Forestry, Fire and State Lands held a ceremony at the Utah State Capitol to recognize the efforts of state and federal leaders who have played a vital role in guiding Utah residents to exercise Fire Sense when they recreate outdoors, use fireworks, burn debris and use firearms.

Water conditions update from Division of Water Resources



As we enter mid-February, Utah's water supply exhibits promising signs of resilience and abundance. The state's snowpack, consistently above normal levels for most regions, sets an optimistic tone for water conditions.

Statewide, reservoirs are currently at an impressive 82%, marking a stark contrast to a regular year, where levels would be around 20% lower. Compared to last year, the increase is more notable, with reservoirs currently standing 32% higher. This reinforces the resilience of our water storage infrastructure.

January storms have played a vital role in boosting the state's snowpack, with southern Utah experiencing particularly significant benefits. Soil moisture

remains in a positive position. This coupled with a above-normal snowpack robust reservoir levels, positions the state favorably as we progress through the winter season. As noted in NRCS's Feb. 1 Water Supply Outlook Report for Utah, every major watershed in Utah received above normal precipitation for the month of January.

Utah unveils inaugural Outdoor Recreation Strategic Plan



The Utah Division of Outdoor Recreation, in partnership with the Utah Outdoor Adventure Commission and Utah State University's Institute of Outdoor Recreation and Tourism, has released the state's first Outdoor Recreation Strategic Plan.

Developed in collaboration with recreation stakeholders from across the state, the landmark plan aims to guide the future for accessible, high-quality outdoor experiences while balancing economic growth with preserving Utah's natural landscapes. The plan, reflecting insights from comprehensive studies and stakeholder workshops, sets forth both immediate and long-term objectives. It emphasizes the importance of responsible stewardship of natural resources and prioritizes community engagement in outdoor recreation development to continue to enhance Utahns' quality of life as more people get outdoors.

Utah Division of Outdoor Recreation to award over \$350,000 to boost youth outdoor programs

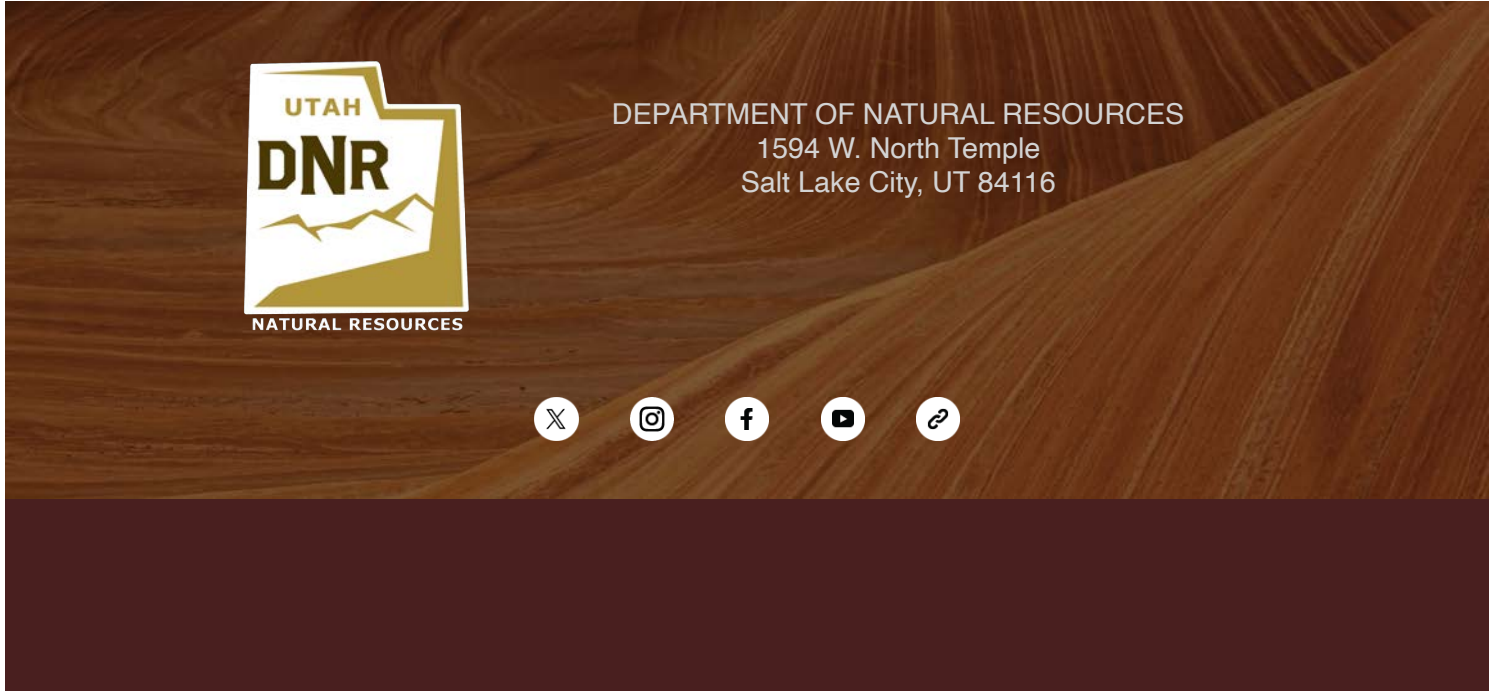


The Utah Division of Outdoor Recreation (DOR) announced the successful conclusion of its 2023 Utah Children's Outdoor Recreation and Education (UCORE) Grant cycle. An impressive \$357,147 was awarded to 29 programs across 16 counties in Utah,

with a significant focus on rural areas. This funding is set to impact more than 16,000 youth and contribute to programs with a combined value exceeding \$2 million. In addition to the UCORE Grant cycle, the DOR announced the recent opening of the 2024 Utah Outdoor Recreation Grant (UORG) application cycle that runs through Friday, March 15, as well as the Off-Highway Vehicle Recreation Grant (OHVR) cycle that is open Thursday, Feb. 1 through Tuesday, April 2. These two programs represent the immense commitment coming from

the state to support outdoor recreation, with \$20 million available between two grant programs. "
